Take highway 98 East towards Bunn. Pass Spencer's Gate housing development. Make the next paved right onto Bethlehem Church Rd. Make the first paved left onto Robbins Rd. At 195 Robbins Rd, veer right to the business driveway. Park in a single row along the fence as indicated by the signage.

From Durham and points West: Take 40 East to 540 East towards Raleigh/Wake Forest. Take Route 401 North. Stay on the 401 Bypass through Rolesville (no turns required). Take highway 98 East towards Bunn. Pass Spencer's Gate housing development. Make the next paved right onto Bethlehem Church Rd. Make the first paved left onto Robbins Rd. At 195 Robbins Rd, veer right to the business driveway. Park in a single row along the fence as indicated by the signage.

From I-95 and points North: Take 95 South to Route 85 South towards Raleigh. AFTER crossing into North Carolina, take the left exit to Route 1 S. Take Route 98 East towards Bunn. Pass Spencer's Gate housing development. Make the next paved right onto Bethlehem Church Rd. Make the first paved left onto Robbins Rd. At 195 Robbins Rd, veer right to the business driveway. Park in a single row along the fence as indicated by the signage.

From I-95 and points South: Take 95 North towards Raleigh. Get off at the Wilson exit for 264 West. 264 merges with 64 West. Get off at Route 96 North in Zebulon. Take Route 96 N to Route 401 North. Take highway 98 East towards Bunn. Pass Spencer's Gate housing development. Make the next paved right onto Bethlehem Church Rd. Make the first paved left onto Robbins Rd. At 195 Robbins Rd, veer right to the business driveway. Park in a single row along the fence as indicated by the signage.
