ENTRY NOTES

- RACH and RAE will be offered as classes. Dogs entered in the RACH class will be entered in Master, Excellent B, and Advanced B, and the combined entry fees for these three classes must be paid. Dogs entered in the RAE class will be entered in Excellent B and Advanced B, and the combined entry fees for these two classes must be paid. Once the limit has been reached for Rally, the RACH/RAE Class will be considered closed, and any subsequent entries for this class will be unacceptable in their entirety.

REFUND NOTES

- Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the show, no refund of entry fee will be made.
- Refunds due to illness or injury of either dog and/or handler will be in the form of a voucher towards a future trial, less \$11 per run. A written veterinarian/physician letter (on office letterhead) must be given to the Trial Secretary no later than one half hour prior to the start of the first class in the trial. Validation of the injury/illness must be made by a licensed veterinarian/physician and attest that the dog/handler cannot compete at this specific set of trials and/or provide a time period during which the dog/handler cannot compete.
